Members present on the call introduced themselves and a mention of recent pottery interests. We last met as a membership in January 2021. Since then our focus has been on space and usage during COVID limitations, working on our processes and launching workgroups. Since then, we have had several committees start up: Education, Finance, and Bylaws review.

The Bylaws review committee was comprised of 2 Full Members, 1 Emeritus Member, 1 Associate Member, and 4 Board members. Over 6 weeks and dozens of hours were spent reviewing the initial Bylaws, which were revised to reflect the current operations and needs of the club, simplifying the elections, removing redundant and unhelpful phrasing, clarifying Board positions and responsibilities, and processes for member and Board member removal. A big thank you to Loretta Hoag, Rebecca Cigal, Delaney Piper, Suzanna Hunter, Vince Lanzone, Toan Tran, Scott Mc Veigh for joining me in this workgroup.

Our COVID policy continues to be consistent with NYS and CDC requirements. If you are vaccinated, masks are not required, if you are unvaccinated you will continue to wear a mask at the studio. We have 12 sign up slots open, which allows everyone to plan visits, and maintain the ability to keep six feet physical distance.

Membership Report Presented by Toan Tran

Current Member numbers:

Full: 42, Associate: 26, 6 Working, 2 Emeritus We have had a robust waiting list during Covid, and we will be welcoming new members soon. New associate members will be joining in July. New full members should be coming shortly thereafter.

Activities:

- 1. Shelf capacity is recorded at 67 shelves, and a tab in the membership file on google drive now informs us of shelf space availability, 50 are used, 15 are unused with 2 used for slow cooled firing.
- 2. A membership survey was sent out in April and was attached to the meeting invitation to gather important member input on usage and expectations. A report followed in June and a second member survey was sent out about these issues:

- i. One issue covered was the number of pieces that should be covered in full member dues.
- ii. The vote for this issue is current, but ends 6/23.
- iii. Other issues included are:
 - 1. associate member firing fees and day passes,
 - 2. Firing costs/kiln rentals.

Forthcoming Activities

- 1. New member procedures and updated contracts.
- 2. A kiln committee structure has been written to standardize firings, report issues, and handle special firings (like raku, pit, and kiln rentals).
- 3. A glaze lab is being established, raw materials have been delivered and a process is underway to help members create custom glazes.
- 4. Raku firings will be repeating. Slated date 6/27. Perhaps other kinds of firings in the future.

Vice President/Education Report presented by Maureen Hanley:

The Ed Committee has been busy! Last fall we held three classes which went well and we learned a lot along the way. We ran into some firing backlogs and realized we have to stagger classes in the future. The fall classes were open to members and non-members. Because of covid we offered no additional classes in the spring. We did have some amazing socially distanced workshops!

Workshops: Lee Glasheen did a recorded decal application demonstration in the fall. Sue Novogradski held a Zoom workshop on Surface Design in January. Don Seymour of clayscapes did a Zoom workshop on glazing in February. In March we recorded a demonstration on the use of the extruder. In April, a workshop on Layered Colored Slip technique was given by Mary LaFleur. Mary Pat and Colleen donated their talent and time to hold a Raku Firing, which was loved by all and we hope to repeat again this summer. Thank you, Barb Constanzo and Scott McVeigh, for recording these!

Upcoming classes: This summer we are having two sections of 6 students each entitled "Back to Basics" taught by Toan on Tuesday and Thursday evenings starting mid-June. These are open to members only and the students will bring their own clay. We found the recent member sentiment survey very helpful in guiding the formation of these workshops.
